

PREPARATION MEMO - PARTNERS

The School Redesign Summit will be an opportunity for LEAs and school redesign organizations to begin brainstorming strategies to improve the achievement of each persistently struggling school. PARTNER PREPARATION & ENGAGEMENT

The following information provides more detail on what partners can expect to experience at the Summit and should be helpful in preparing for a productive day.

TIME	AGENDA	PARTNER PREPARATION & ENGAGEMENT STRATEGIES
8:00-9:15	Opening Plenary	
9:20-10:05	Partner and State Huddle	PARTNER ROLE: Partners will learn about Louisiana's educational context, current initiatives LDOE is undertaking, state-wide successes and areas of needed growth, and collect information which will inform potential partnerships with districts.
10:15-11:40	Partner Conversations, Round 1	This time block will be broken down into seven 10-minute segments. During each 10-minute time block, district teams will hear from a different partner. Districts and partners will receive their schedule for this time block by Tuesday, January 17th. PARTNER ROLE: Each partner will use approximately 5 minutes to share information about their organization and 5 minutes to answer questions. Partners should bring enough paper copies of any presentations or materials to distribute and be prepared to repeat seven times the same presentation for different district teams.
		DISTRICT ROLE: Districts should use this time to gather additional information, ask questions, and make preliminary decisions about whether to pursue next steps with each partner.
11:45-12:25	Partner and State Huddle	PARTNER ROLE: Partners should come prepared to discuss the conditions needed for your organization to be successful in a particular district or in the state of Louisiana.
1:20-2:55	Partner Conversations, Round 2	This time block will be broken down into three 30-minute segments. During each 30-minute time block, district teams will present their most pressing challenges to partners and discuss how a potential partnership might look.
		PARTNER ROLE: Partners should use the presentation segment to gather information and ask questions to better understand the challenges each district faces. Partners will discuss with select districts the solutions they can bring through a partnership with that district.
		DISTRICT ROLE: Teams will spend the first 5-10 minutes of each 30-minute session presenting information on the select schools they are most focused on for 2017-2018. Teams will use this time to describe relevant student, teacher, administration, and district-level challenges, the reasons for those challenges, what has and has not worked previously in improving student outcomes at these schools, and what they want to prioritize at those schools. Districts and partners will then explore further what it may look like to work together.
