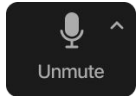

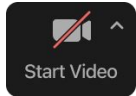

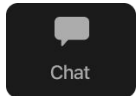

Per a [2017 AE Study Group Report](#), students in Louisiana alternative education settings rarely receive the necessary academic and behavioral support needed to address the root cause of their exit from the home school.

**Gaps in the services provided often mean that students experience inconsistent transitional procedures upon entry or exit from the alternative school or program.**
