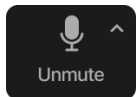
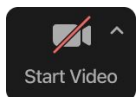


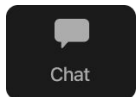

# Certification Processing by the Numbers

- April 2025
  - 2582 Applications Processed
  - 99.85% Processed within 15 Business Days
  - Average Processing Time = 6.5 Business days
  - 1085 Questions Solved
  - Questions Solved within 0.8 Business Days Average
- May 2025
  - 2788 Applications Processed
  - 100% Processed within 15 Business Days
  - Average Processing Time = 5.25 Business days
  - 1213 Questions Solved
  - Questions Solved within 0.9 Business Days Average

# Required Reporting

Employing school systems shall notify LDOE (within 10 days) if a credentialed educator resigns or is terminated due to:

- Felony conviction or plea (including all crimes in [R.S. 15:587.1](#))
- Test security violation or cheating

LDOE will notify the educator in writing, giving 10 days to dispute or verify mistaken identity.

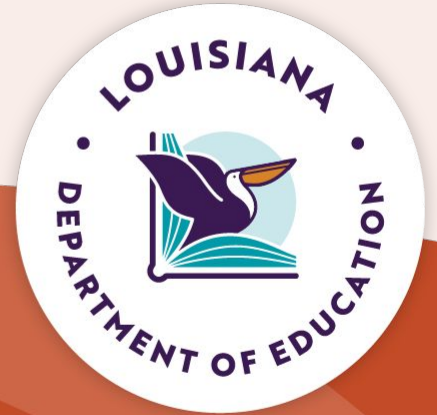
Other reporting pathways include but are not limited to:

- Rap backs
- Anonymous tips
- Third-party reports (media alerts)
- Educators self-report

# Louisiana Educator Certification Portal

## Tentative Implementation Plan

- Alpha testing - Beginning June 16 (two weeks)
- Beta testing - Beginning July 7 (two weeks)
- Anticipated launch date - July 28

## Authorized User Partnership Planning

- Training sessions for all authorized users are anticipated during beta testing and initial launch periods - watch for future announcements
- Once LEC is launched, the window to submit any remaining PDF applications will be approximately two weeks.
  - Plan to submit any PDF applications quickly as we approach the launch date for LEC



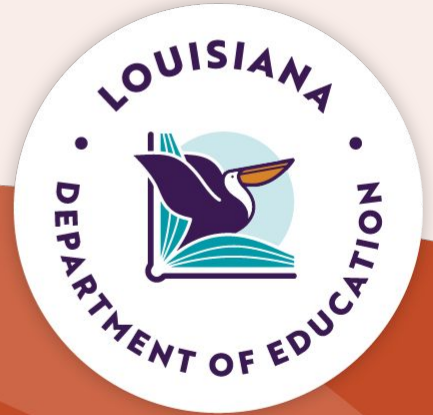
# Louisiana Educator Certification Portal

Additional updates include:

- Requesting two or more areas on the CTTIE application will require a \$25 processing fee
- Requests for Course Approval for more than four courses will also require an additional processing fee
- All applications and follow-up submissions will be initiated by the **educator**.
  - HR and Prep can send a request to start the application
  - Automated routing to HR &/or Prep for additional verification
- Automated CBC/Clear Credential verification - Applicants will be unable to start an application unless a CBC/Clear Credential is on file

# Content Leader and Mentor Teacher

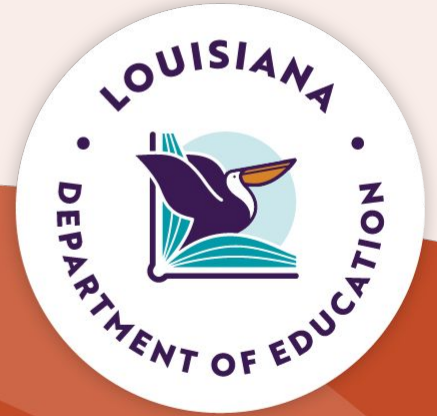
If any vendor that is interested in becoming a vendor to assess the content leader and mentor teacher portfolios, we have a tentative launch date for applications for June 24, 2025.

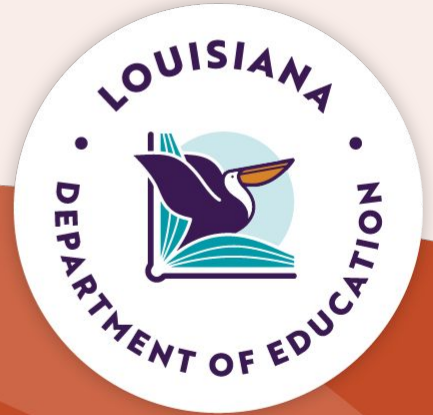

# Changes to Resident & PL Application Process

When the new Louisiana Educator Certification (LEC) portal is launched, some of the new applications will require additional documents or verifications.

- Practitioner License (PL) Application
  - The Intent to Employ, completed by human resources, will require the assigned Mentor's name and a copy of their Mentor credential or waiver
  - A request to change **provider** or **program area** will be made on the initial PL application with a required upload of a withdrawal letter from the previous provider or area
  - A request to change **program type** with the same provider and area may be requested with the PL renewal application



# Changes to Resident & PL Application Process

When the new Louisiana Educator Certification portal is launched, some of the new applications will require additional documents or verifications.

- Resident Teacher (R) Application
  - Verification from the hosting school system will be added, similar to the Intent to Employ, to be completed by the hosting HR office
  - Will require the assigned classroom-based Mentor's name and a copy of their Mentor credential or waiver
  - A Plan of Study will be required, similar to the PL
  - Applications for alternate-certification candidates will include verification of program admission requirements similar to the PL

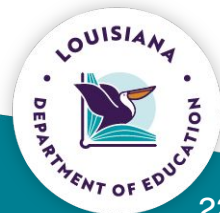


# Content Leader Assessments

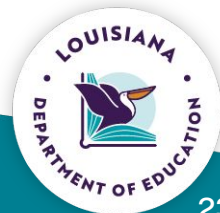


# Mentor Teacher Assessments
