ESSA	ESSA Framework	Passed by Congress in 2015, ESSA is a federal law that requires states to have a plan for spending federal funds, for measuring the skills students learn, and for supporting students in making academic progress. This session will provide school leaders with an opportunity to learn about and provide feedback on critical shifts in the design of Louisiana's schools and district accountability system being considered as part of the state's ESSA framework .	• All
Curriculum, Professional Development & Assessment (K-12)	Am I Doing This Right? Curriculum Implementation, Part 2	In this session, participants will investigate what it takes to increase student achievement by improving teachers' ability to implement a high-quality curriculum. Participants will evaluate sample professional development plans against a set of criteria and discuss what it would take to offer more content-rich and curriculum-based professional development in their own districts. This session builds on the September collaboration session during which supervisors practiced using the curriculum implementation scale to evaluate the quality of implementation in a sample district in preparation for conducting a similar analysis in their own districts. Early Childhood	Practice Performance Profiles – Supporting Understanding and Action after the Roll Out	How were the 2015-2016 Practice Performance Profiles received in your community? The Early Childhood team wants Lead Agencies to come to this session prepared to share the details of their interaction with partners around the results. What were the big questions, concerns, and celebrations? Additional discussion will focus on your plans to keep partners focused on their data and how to influence positive change. Early Childhood	CLASS Calibration – The Importance of Accuracy in the Local Observation Process	Accuracy is the best policy! Local observations are the engine that drives the train to have more children ready for kindergarten. One of the takeaways from the Learning Year is that there is an opportunity to improve the accuracy of local observations. The Early Childhood Team will review the requirements that have been put in place to support local accuracy. Participants will hear their peers share calibration procedures that they have implemented and whether there is evidence of improvement at this point in the year. Early Childhood - Kindergarten	Instructional Leadership – Collaborating to Align PreK and K	Practice Performance Profiles point to the need to improve instructional support at many early childhood sites across the state. With the focus on preparing every child for Kindergarten, this session invites elementary supervisors, curriculum coordinators, academic officers and assistant superintendents to join Lead Agency contacts for a discussion on fostering collaboration between PreK and Kindergarten teachers to focus on preparing at-risk four year olds for Kindergarten. Guidance for developing partnerships and participating in support opportunities will be provided and include opportunities for collaboration and feedback. Data Governance	Exploring Data Governance Training Resources and Louisiana's Data Governance and Student Privacy Guidebook	In this session, participants will review materials to use when training students, teachers, and staff about data governance and privacy. Additionally, the 2016-2017 Data Governance and Student Privacy Guidebook will be shared and discussed. Leaders will leave this session equipped with a training plan and tools to move forward in their data governance plan.	Data governance supervisors
