Financial Aid Policy

In December 2015, the Board approved a revision to Bulletin 741, *Louisiana Handbook for School Administrators*, which requires that public school students graduating spring 2018 and beyond have taken one of the following steps as part of their Individual Graduation Plan:

- Submit the <u>FAFSA</u>
- Complete the Louisiana TOPS form
- Submit an opt-out <u>non-participation form</u>
- Receive a <u>waiver</u> through school system

Several resources are available on the <u>Financial Aid webpage</u> to support schools in ensuring students meet this graduation requirement.

The Individual Graduation Plan (IGP)


- connects student's academic and career goals with postsecondary and/or workforce plans,
- tracks high school graduation requirements,
- indicates completion of financial aid planning, and
- includes signatures from legal guardian and student.

Students can download the LDOE <u>fillable form</u> and save/upload that document to the school system's platform for hosting IGPs, which can include

- school system-identified career planning system,
- student cumulative folder, or
- LOSFA Student Hub.

Jump Start Updates

Students graduating with a Jump Start TOPS Tech diploma must earn one or more industry-based credentials (IBCs) to meet graduation requirements. Accountability implications of IBCs

- Regional Credential: **100** index points
- Statewide Basic Credential: **110** index points
- Statewide Basic Credential *and* one passing course grade in AP, college credit, or IB: **115** index points
- <u>Statewide</u> Advanced Credential: **150** index points

Jump Start Summers provide students with IBCs, internships/work-based learning, and a stipend.
