A charter school's founding team is composed of motivated stakeholders who take the initiative to apply for and open a charter school that they feel will meet the needs of their students and communities.

- Founding teams make key decisions that will determine the school's governance once the charter school opens:
  - How future school board members will be nominated and selected;
  - What the role of parents and the community will be in school governance;
  - Procedures for committee formation and structure; and
  - What criteria will be used to nominate and select the school leader.



Often, one of the founding team members, "the founder," is the central leader behind the inception of the charter school. Once the school opens, the school leader will be responsible for managing the charter school, fulfilling the school's mission, and realizing the goals and priorities set by the board.

- School leaders often have some autonomy regarding curriculum, programs, and hiring staff.
- The school board, though, will make key decisions about the school's governance and performance goals and will evaluate the school leader's progress towards these goals.
- It is crucial that the school board and the school leader fulfill their roles of governing and managing the charter school, respectively.



As an authorizer, it is your responsibility to determine the capacity of the founding team at the application stage.

- Aim to evolve the application process in order to "shift rigor from paper to people" (NACSA).
  - The ability to effectively identify and assess a founding team's capacities can improve your ability to approve applications of schools more likely to succeed.
  - Capacities should observable: it is the means by which a founding team executes on plans and responds to changing circumstances over time.
    - Touchpoints to assess the team's ability to adjust and adapt, while still executing on its vision.
  - Objectivity over bias: making decisions based on evidence.



NASCA published *The Capacities of Charter School Founding Teams* in March 2025, which identifies 9 key areas of capacity that authorizers may used in determining how to assess overall capacity for school success:

- Strategic Focus on Mission
- Community Commitment
- Building a Coalition
- Reflective Learning
- Creative Problem Solving
- Effective Decision Making
- Relationship with Success and Failure
- Team Awareness
- Knowledge, Skills, and Execution

Rating Capacity:

Meets the Standard: Evidence is multi-faceted and demonstrates that the team members, as a whole (or multiple individuals on the team), substantially meet the criteria for the given capacity.

Partially Meets the Standard: The evidence demonstrates that the team members, as a whole (or multiple individuals on the team), meet the criteria for the given capacity in some respects, but is not observed in multiple instances or with sufficient completeness.

Does Not Meet the Standard: The evidence is wholly insufficient or significantly lacking; or opportunity was provided to demonstrate the given capacity and the founding team did not provide demonstrative evidence of that capacity.

### Numeracy Professional Learning: Act 260 of 2023

The Louisiana Department of Education (LDOE) has developed a full suite of Numeracy Professional Learning courses for K-12 math teachers. This includes the training required by <u>Act 260 (2023)</u>. Act 260 requires all grade 4-8 mathematics teachers to complete an approved professional learning course that focuses on numeracy skills instruction **by August 1, 2025.**

#### **NEW** Ensuring Data Accuracy: LEA Assurance Statements

Beginning in the 2025–2026 school year, LEAs will be required to submit annual assurances after each final collection of federal and state data.

These assurances will serve as official confirmation that data submitted to SER or within survey collections are timely, valid and reliable in accordance with federal and state guidance that govern data collection and reporting.

More information will be provided in next month's office hours.



### **NEW** 2024–2025 Seclusion and Restraint Assurance

- LEA Verification Reports were uploaded to the Data Management (DM) FTP on June 4 with action to be completed by June 30.
- LEAs will be required to complete and submit an assurance that certifies that the data in SER is accurate, valid and reliable.
- An updated version of the 2024-2025 LEA Verification for Seclusion and Restraint report with signature sections will be available in DM FTP by July 15.



### **NEW** Ensuring Data Accuracy: LEA Assurance Statements

#### **Steps to Complete the Seclusion and Restraint Assurance Statement**

- 1. **Retrieve** the updated version of the 2024-2025 LEA Verification for Seclusion and Restraint report from the DM FTP.
- 2. **Review** Seclusion and Restraint data submitted in **SER** to ensure accuracy.
- 3. **Complete and sign** the report by the appropriate LEA representative.
- 4. **Submit** the signed Assurance Statement by the designated deadline. Details for submitting the signed assurance will be outlined within the submission instructions.



# **Seclusion and Restraint Training**

- HB 684 provides for preparation for all teachers regarding crisis prevention programs, which may be incorporated into an existing course of study for teachers.
  - Currently, a module, Legal Requirements and Practical Considerations for the Use of Restraint and Seclusion, is available for any educator.
- It also states that the Department may develop a crisis intervention training program that may be used by each public school governing authority for those designated individuals on the crisis team who need training on proper use of seclusion and restraint. This will be provided at no cost to school systems.



# Bulletin 741- Louisiana Handbook for School Administrators

- Updates the requirement to include the number of seclusion rooms to the annual Special Education Advisory Council (SEAC) report.
- Updates in alignment with requirement in HB 684 that school systems install a camera regardless of whether a parent has requested a camera in classrooms as defined in R.S. 17:1948. **Effective February 1, 2026**.
