Equitable Services Updates and Reminders

- Send your nonpublic carryover/remaining allocations/funds as soon as you calculate them.
- Please add any notes if needed.
- If you do not have any nonpublic carryover, please send an email stating that your nonpublic schools obligated/expended their allocations/funds.
- For those LEAs that do not have any nonpublic schools with Titles II and IV carryover, send an email stating how you and the nonpublic schools were able to expend, obligate, or reach an agreement to return the allocation to the LEA to be redistributed to both nonpublic and public schools for the 2025-2026 school year.

Equitable Services Updates and Reminders

- Some LEAs are experiencing school closures this year.
- Be sure to have the nonpublic administrator and/or the Diocese Superintendent, Headmaster, CEO, etc. send an official letter on school letterhead to the LEA stating the school is officially closing.
- Follow your LEA's inventory process for picking up items from the nonpublic school and update any required documentation.
- Remember, all items purchased with federal allocations are the property of the LEA and or SEA.

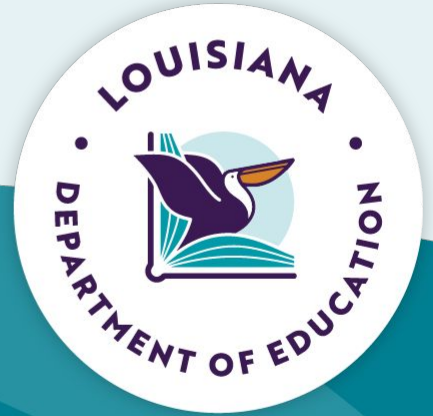
CSI/TSI Plan

2025-26 Super App: Amendment 1



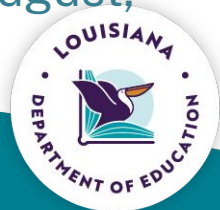
2025-26 Super App

- **2026 LEA Central Data**

- All Contact Information and Assurances that are associated with the awarded funding must be completed in order to submit Amendment 1 of 2025-2026 Super App
- Common and Nondiscrimination Assurances should have been completed on or before **April 18, 2025**

- **Allocations**

- Estimated Formula allocations (ESSA, IDEA, Carl Perkins), and competitive allocations are now available.
 - Estimated formula allocations are 90% of the 2024-25 final allocations
- Formula funding: Preliminary allocations will be available in August, and Final allocations in December.



2025-26 Super App

- **Review Process**

- Amendment 1 will progress through the standard review levels
 - Level 1 Programmatic and Fiscal review
 - Level 2 Programmatic and Fiscal review
 - Final review

- **Submission Deadline**

- In order to meet the requirements for Substantial Approval, Amendment 1 for the 2025-26 Super App must be submitted on or before close of business on June 30, 2025.

2025-26 Super App Changes

- Instead of the application being divided by “Priority” tabs, the application now displays by “Section” tabs
- Each Section, except Section 7, includes at least one budget detail page.
 - Note: Section 5 includes two budget details
 - **EL/Attendance budget detail:** captures activities for the EL population
 - **SWD budget detail:** captures the activities for the SWD population
 - The **Nonpublic budget detail** is housed in the Administration section of the application.

- **Title IV Program Objective tab revised to include:**
 - Public and Nonpublic tabs
 - Dropdown to identify number of objectives for Well-Rounded, Safe and Healthy, and Technology

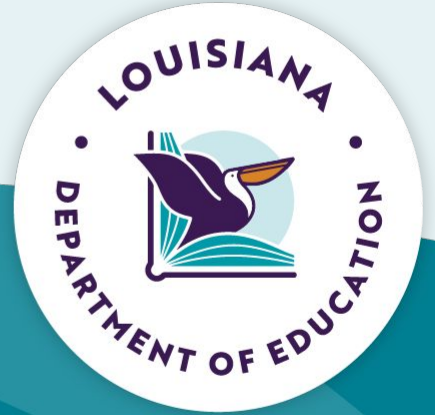
FY23 ESEA Waiver Request

Response received from ED

- The feedback received strongly encouraged the drawdown of FY23 funding by the end of availability - 9/30/2025
 - Note: this is your 2023-24 funding that is set to expire as of 9/30/2025
 - Due to the tydings waiver we received on the FY22 funding, these funds (2022-23) are also set to expire as of 9/30/2025
 - Our Federal Programs team has been doing outreach on remaining FY22 and FY23 funding.
- ED referenced formula funding is provided on an annual basis and should be expended during the 27 month availability period

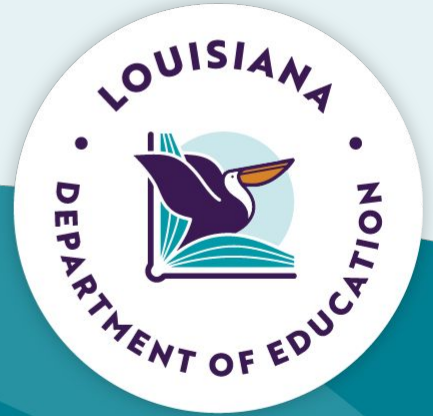
