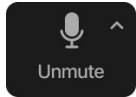
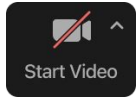


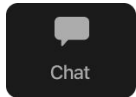

2025-2026 Super App Launch



School System Planning

The 2025-2026 Super App in-person launch will take place on **October 17** at LAFEPA (formally LASAFAP).

During the launch, the *Next Level Vision for Success School System Planning & Budgeting Workbook*, inclusive of 2025-2026 Super App questions, will be released.

New for 2025-2026

- The *Next Level Vision for Success School System Planning & Budgeting Workbook* serves as a one-stop resource for all school system planning needs.
- Super App questions and funding are aligned to the LDOE's updated educational priorities.
- The updated application in eGMS automates the review process and simplifies the steps of Super App submissions to ensure alignment with ESSA requirements for labeled schools.
- LEAs will be required to identify ESSA-required comprehensive support and improvement strategies to improve student outcomes.

Federal Support Updates

- Notices will be provided to inform school systems regarding their 2020-2021 funds that must be obligated on or before 9/30/24.
- The LDOE received a waiver extending availability period for 2022-2023 funds until 9/30/2025. Please note that McKinney Vento is not included in this waiver.
- A third notification email was sent to inform LEAs of expiring fund balances to prompt expeditious claim submissions and ultimate draw down.
- Notifications have also been sent to districts that have not submitted its 6/30 PER. Without it, prior year amounts cannot be loaded in their 2025 Super Ap.

Budget Reminder

McKinney Vento 22-23 and Homeless ARP I & II Funds expire 9/30/24. The amended liquidation process allows LEAs to continue receiving goods/services secured with Homeless ARP I and II funding through early December 2024.

Tip: Please transition any encumbered expenditures to the 22-23 & ARP Homeless budgets. This strategy will free up the MV 23-24 and 24-25 budgets.

Equitable Services Updates and Reminders



Friendly reminders for NP schools that affect services...

LEA's please share the information below with your nonpublic schools. This helps the agency get the Nonpublic School Academic Classification list generated on time to start collecting documentation, having the required meaningful consultations and preparing the eGMS applications for the 2025 -2026 school year. THANK YOU!!!

- **The application for nonpublic schools seeking BESE (Board of Education & Secondary Education) approval for the 2025-2026 school year is now available and will close on October 15.**
- The applications are being received via [jotform](#), which is located on our [Nonpublic Schools](#) webpage.
- All applications must be complete when submitted. If missing or incorrect documents are attached to the application, it may cause a delay in moving through the BESE approval process.
- The [Brumfield v. Dodd Initial Application](#) or [Annual Compliance Report](#) must be complete in its entirety and attached to your school's BESE application via [jotform](#), along with the school's nondiscriminatory policy and supporting documents.

Only BESE approved non-profit schools may receive equitable services.



Friendly reminders for NP schools con't...

- Please remind nonpublic schools that they do not receive direct funding; they only receive allocations for services.
- The agency's Ombudsman still receives calls from nonpublic school officials about not having access to direct funding (i.e. Title I funds). Let's continue to correct our nonpublic schools and LEA staff if needed to understand the process and use the right terminology.
- Remember, the LEA Nonpublic Title I Program is for the LEA to provide tutoring, counseling, etc. services to the nonpublic students who are endangered of failing, not the nonpublic school administrators.
- Title I programs for non-public schools do not operate like LEA's public Title I program. This program functions more like a LEA/school district targeted assistant program.

- And, please do the same for LEA/school district entries as well.

Updates

- **2024-25 Preliminary Allocations (formula funding)**
 - Preliminary allocations for ESSA and IDEA have been loaded in eGMS.
 - Remember that an amendment should be submitted within 90 days when the award amount changes to not disrupt the reimbursement process.
- **2024-25 IDC Rates**
 - The 2024-25 IDC rates have been loaded in eGMS.
 - These rates will now be reflected in all 2024-25 applications.



Updates

- **Change in Allocation Notices**

- eGMS has begun sending a “change in allocation” notices
- The system will check allocations twice a month, and send out notifications that an amendment is needed if there is a change in award amount.
- Amendment should be submitted within 90 days of the change in award amount.

- **October FSGR Call**

- Adjust your calendars for the October FSGR Monthly Call. This call will occur on October 10, 2024.

- The 2024-25 EEF application has been released in eGMS
- LEAs should create the application, and begin working toward submission of the application
- Deadline to submit the 2024-25 EEF application is October 10, 2024.

Equitable Services Prior Year Funds

- **Equitable Services Prior Year Fund in Super App**
 - An Equitable Services Prior Year Funds tab has been added to the 2024-25 Super App to help LEAs capture the private school carryover amounts.
 - The tab is located under the NonPublic tab in the Super App application
 - This tab should be completed first (prior to completing the Title I Targeting Step 4 tab, ESSA Equitable Share tab, and the Title IV Allowable uses tab)
 - Amounts provided on the Equitable Services Prior Year Funds tab will be transferred to the tabs listed above.

NOTE: We have identified that a portion of the prior year funds is not being captured in the current design. An update will be made to address the issue.



ESSER III Funding



Amended Liquidation Protocols

- **ESSER III and Homeless ARP I and II Obligation Date: 9/30/2024**
 - Amendment liquidation does not change the obligation date of the funding.
- **Amended Liquidation Date: 12/16/2024**
 - LEAs have until 12/16/2024 to receive goods and services
 - Note: subscription costs - if subscription costs are obligated on or before 9/30/2024, and the invoice is paid on or before 12/16/2024, services may continue through the 2024-25 school year.

Note: All ARP ESSER claims/PERs must be submitted on or before 12/16/24.
(A 12/16/2024 PER has been added to ESSER III which will be marked as the final PER.)

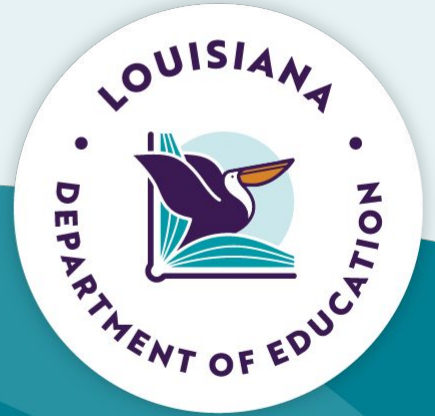


ESSER III Reallocation

- The staff are currently reviewing the data obtained from the LEAs regarding the release of any unobligated ESSER III funding.
- As required in the reallocation Protocols, the Agency must ensure that the adjusted allocations still maintain the 20% requirement for Evidenced Based expenditures
- Qualifying districts will receive their allocations on or before 9/27/2024.
- Any additional funding received via reallocation can only be used on expenditures that were obligated on or before 9/30.



FY22 ESEA Waiver



ESEA WAiver

Approved by ED on August 27, 2024. The Waiver covers the following:

- Carryover limitation in section 1127(b) of the ESEA for Federal fiscal year (FY) 2023 Title I, Part A funds (i.e., the Title I, Part A funds that will become carryover funds on October 1, 2024): to waive the requirement that limits a State educational agency's (SEA) ability to grant to its LEAs a waiver of the 15 percent Title I, Part A carryover limitation in section 1127(a) to once every three years.
- Period of availability of funds in section 421(b) of the General Education Provisions Act: to extend the period of availability of FY 2022 funds for programs in which Louisiana participates under its approved consolidated ESEA State plan until September 30, 2025.



ESEA Waiver

The programs include:

- Title I, Part A of the ESEA (Improving Basic Programs Operated by LEAs), including the portions of the SEA's Title I, Part A award used to carry out section 1003 school improvement, and Title I, Part D, Subpart 2
- Title I, Part B of the ESEA (State Assessment Formula Grants)
- Title I, Part C of the ESEA (Education of Migratory Children)
- Title I, Part D, Subpart 1 of the ESEA (Prevention and Intervention Programs for Children and Youth Who Are Neglected, Delinquent, or At Risk)
- Title II, Part A of the ESEA (Supporting Effective Instruction)
- Title III, Part A of the ESEA (English Language Acquisition, Language Enhancement, and Academic Achievement)
- Title IV, Part A of the ESEA (Student Support and Academic Enrichment Grants)
- Title IV, Part B of the ESEA (21st Century Community Learning Centers)
- Title V, Part B, Subpart 2 of the ESEA (Rural and Low-Income School Program)

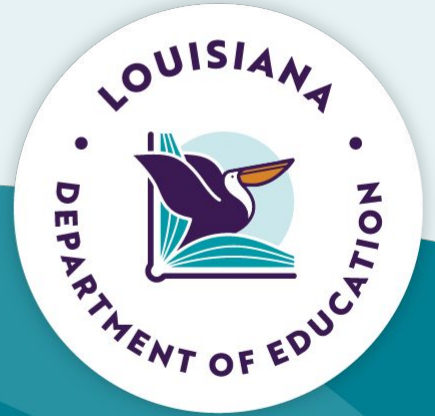
- **When:** October 16-18, 2024
