## School Safety Act of 2023

The Louisiana Commission on School and Nonprofit Security, hereinafter referred to in this Section as the "commission", is hereby established within GOHSEP to study and make recommendations on the security needs of schools and nonprofit organizations that are at high risk of terrorist attacks in Louisiana, including recommendations on the establishment, administration, and funding of a grant program for eligible entities to apply for security grants covering security personnel, security training, facility hardening, and other necessary security measures.

The commission shall provide oversight of the Louisiana Center for Safe Schools. The commission shall annually report to the governor on the activities of the center and any identified needs of the center. The commission shall provide recommendations to the legislature relative to legislative changes for increasing school safety.

#### **Data Call Questionnaire**

To ensure compliance with the School Safety Act and provide support in improving school safety programs, the Louisiana Center for Safe Schools at GOHSEP in collaboration with SDMI of Louisiana State University conducted a statewide data call with all K-12 schools.

The Questionnaire includes the topics in compliance with the School Safety Act of 2023 such as security assessments, crisis plans, emergency notification platforms, anonymous reporting, district threat assessment teams, SROs and more. These details establish baseline data for future federal and state funding applications in school safety.



#### **Data Call Questionnaire**

- March 2024 Current Statewide Data Call creates a baseline operating view in compliance with the legislative mandates and national best practices for each campus statewide.
- <u>March 2024 Current</u> Creation of ESRI powered Dashboards displaying all schools, data call metrics, and other critical school safety information for solution expansion.







## School & Nonprofit Security Grant Program

The Fiscal Year Louisiana School and Nonprofit Security Grant Program (LSNSGP) (FY) 2024 is a competitive, State-funded grant program for local school systems and non-profits to fund school safety projects which prevents potential acts of violence or other extremist attacks, priorities include: physical and security enhancements, enhancing the protection of soft targets/crowded places, effective planning; training and awareness campaigns; and exercises.

300+ grant application were received for consideration.

#### LCSS's Grant Priorities

- 1. Physical security enhancements
- 2. Enhancing the protection of soft targets/crowded places
- 3. Effective planning
- 4. Training and awareness campaigns; and
- 5. Exercises

Grant project periods are usually 9-12 months.

#### FY2024 Common Items Found

- Applying for more than \$50,000 (Highest Amount we are awarding)
- Applying for more than 1 school on 1 application. We can't tell the needs of each school in 1 application.
- Application states deficiencies and needs, but school is purchasing other items that do not correlate.
- No Sustainability plan given after grant funding ends.
- Budget items did not explain need. Some applications budgets did not provide an explanation of items listed.



## **FY2024 Grant Progress**

- We recently awarded 100+ grants at our June 2024
   Commission Meeting. Grant application submissions closed on May 15, 2024. GOHSEP reviewed them all.
- Everyone began their projects after signing the CEA and Award letter at the end of June.
- All award funding is currently pending CEA approval from the Department of Administration (DOA). Awardee CEAs have been sent to State Procurement at DOA for review. Once the CEAs are approved by State Procurement, we will notify all awardees through GMPro emails.



## **FY2024 Grant Progress**

- Following the approval of the CEAs, we anticipate having GMPro ready for awardees to upload reimbursement packages. GMPro is currently building that piece out and will go through testing prior to deployment. Once it is ready, training aides will be sent to each awardee with how to steps on uploading reimbursement packages.
- GOHSEP employees will be starting in September/ October 2024 (depending on the hurricane season) monitoring/ site visiting all grant awardees before their grants close.

#### FY2025 School & Nonprofit Security Program

Currently we are awaiting additional funding from the legislature. We anticipate another fiscal year of funding to begin soon, but do not have a date available at this time.
