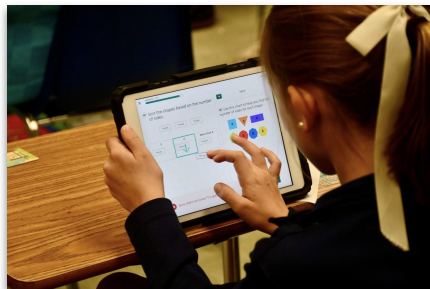

- Identify recommended steps for the implementation of an approved CIR/UIR strategy.

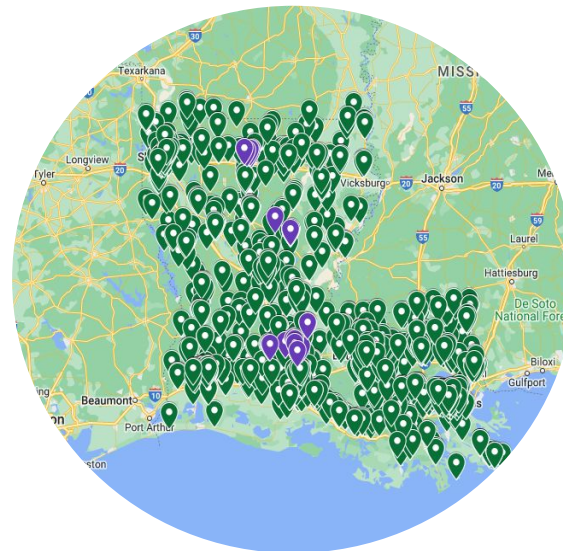

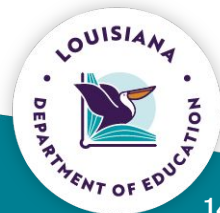


Bulletin 1508: Effective Date and Applicability

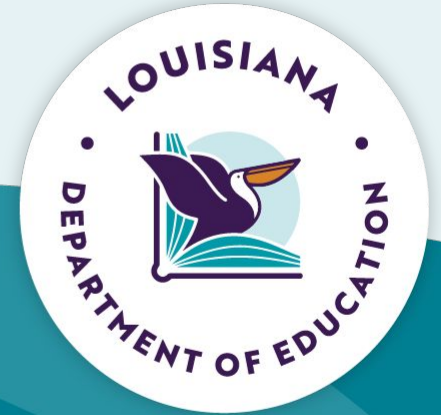

- **February 1 MFP** - Data must be submitted to EdLink 360 by **Wednesday, February 11**, no later than 5 p.m.
 - Primary data used for funding
 - Data quality and on-time submissions are vital to receiving the appropriate funds.
- **February 1 Staff Vacancy** - Data must be submitted to EdLink 360 by **Wednesday, February 25**, no later than 5 p.m.
 - This vacancy data is vital to ensure that state and system leaders have “real-time” data to inform their decision-making process.
- **VAM Roster Verification (View Only)** is now available for teachers and school leaders in the **Louisiana Educator Portal (LEP)**.
 - Ensures teachers are assigned to the correct courses and rosters of students for value-added model (VAM) analysis.
 - The verification window opens on April 20.

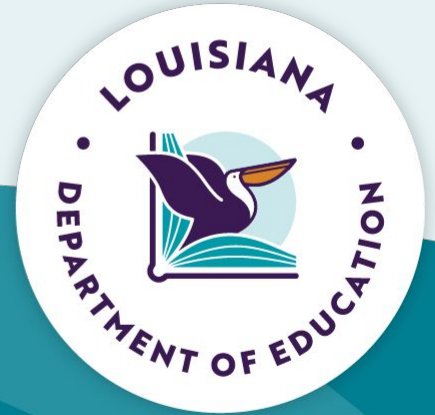

2025-2026 Graduate Diploma and Seal Orders

The [Diploma and Seal Order Form](#) is now open to request diplomas and seals for 2026 high school graduates.

- The electronic form should be submitted by Friday, February 13.
- Only one form should be submitted for each school system. The Department of Education will cover the cost of the initial order and distribution.
- Each school system should order 10% over the number of diplomas needed. This overage will take care of misprints, late enrolled students, etc.

2025-2026 CDF Mid-Year Report

The [2025-2026 Mid-Year Career Development Fund \(CDF\) Mid-Year Expenditure Report](#) is available for school systems to complete.

- The deadline to report mid-year CDF expenditures is February 20.
- School systems should reference the [2025-2026 Guidelines for Use of CDF Allocation](#) when completing the form.
- CDF funds support increased student access to high-value Career and Technical Education courses and training.
- CDF funds are 6% of the MFP State and Local Base Cost Per Pupil (\$241) provided for each qualifying student course enrollment in grades 9-12.

Internship Funding

Funding is available at \$1,000 per eligible student internship enrollment for the spring semester.

- Funding may be used to support all costs associated with providing internship programming to eligible students.

- Must have the [attestation](#) for 2025-2026 school year on file.
- Eligible enrollments will be funded in the order in which they are submitted.

Registered Apprenticeship Funding

Funding is available for approved Registered Apprenticeships in the spring semester.

- \$2,500 per non-rural, \$3,500 for rural enrollments as defined by the United States Census Bureau.
- Funding may be used to support all costs associated with providing apprenticeship programming to eligible students.
- Must be enrolled in [Course Choice Portal](#) by March 7 (send enrollment spreadsheets to coursechoice@la.gov).
- Eligible enrollments will be funded in the order in which they are submitted.

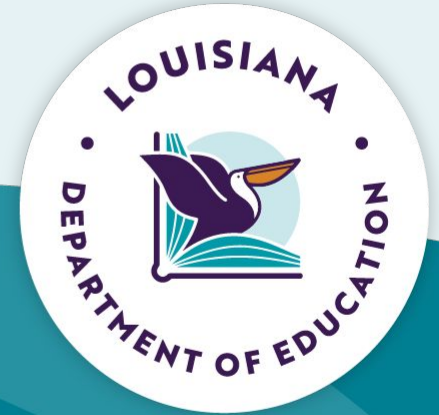

Excellence in Authorizing Community of Practice

The 2026 Excellence in Authorizing Community of Practice will convene in the coming months.

2025-2026 Annual RFA Application Cycle

The application cycle opened on February 2, 2026 for Type 2 and 4 charter schools slated to begin operations in August of 2027.

Applicants must meet the eligibility requirements listed in LA Bulletin 126, §503 and must meet each of the below deadlines to be permitted to move to the next component of the application cycle.

- **February 9 (5 p.m.):** Letter of Intent due
- **March 9 (5 p.m.):** Eligibility Determination Form due
- **March 30 (5 p.m.):** Full Application and Overview Template due
- **August 18:** BESE considers applications for new Type 2 & 4 charters

Criminal Background Checks for Employment

- [LA R.S. 17:15](#) requires employers to direct employees to obtain a state and federal criminal background check (CBC) and defines “employees”.
- [LA R.S. 15:587.1](#) requires all background checks for **school employment** to be conducted through the [Louisiana State Police \(LSP\) Bureau of Criminal Identification and Information](#).
- Third-party background check businesses do not provide fingerprint-based CBCs run through LSP’s Bureau.
- Charter schools may rely on certificated employees’ “Clear Credentials” for employment CBC, but nonpublic schools and non-certificated employees are required to obtain the CBC for employment.

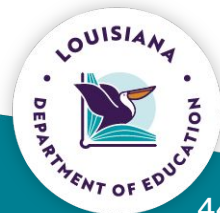

Early Childhood Care and Education

- The Spring 2025 CLASS® observation period has begun for early childhood classrooms at publicly funded sites.
- Community Network Lead Agencies have started the Child Count process by working with sites to count all publicly funded children served at each publicly funded site as of February 1.

Early Childhood Care and Education

LDOE is currently conducting new Early Childhood curriculum reviews designed to evaluate the alignment of instructional materials with the revised *2024 Early Learning and Development Standards (ELDS)* to ensure that materials support high-quality teaching and learning.

- By mid-February, a new Tier I Curriculum List for ECE will be published as reviews are completed.
 - This updated list will only include instructional materials that are aligned with the 2024 ELDS and meet the criteria of the 2025-2026 Instructional Materials Review (IMR) rubric.
- Current Tier I materials were reviewed using previous standards and do not fully align with the 2024 ELDS.
 - As a result, these materials will be archived and will no longer appear on the active Tier I list.
 - *Note: The use of an archived curriculum will not count against site Performance Profiles*

Early Childhood Care and Education

To strengthen early literacy instruction, support early identification, and improve kindergarten readiness statewide, the LDOE is providing funding to support high-quality curriculum implementation and targeted teacher professional learning in publicly funded pre-K classrooms. Funding will be available February 1, in eGMS and will support the following:

- **Tier I Curriculum Implementation:** CNLAs will receive funding to purchase newly-rated Tier I pre-K curriculum, covering up to 100% of costs.
- **Science of Reading Training Educator Stipends:** Pre-K teachers, including those who teach young children with disabilities, who complete the LDOE-developed Science of Reading (SOR) training in Canopy will receive a stipend of \$250.
 - The stipend will be issued by school districts directly to teachers who complete 3 of 6 modules by June 30, 2026.

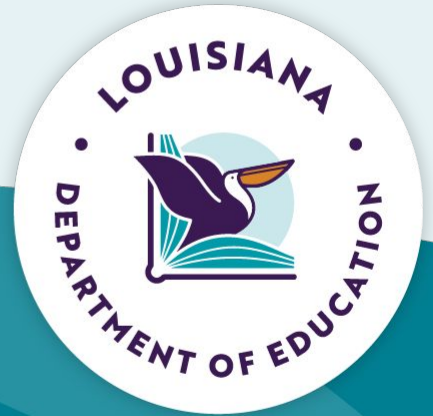
