# Federal Funding

- 12/31 Periodic Expenditure Reports (PERs) are due January 15, 2026.
  - This quarterly report can be used to assess the rate of drawdown for each funding source.
- Final allocations for Formula funding (ESSA, IDEA and Carl Perkins) was loaded in eGMS the last week of December.
  - Due to potential funding changes with final allocations, an amendment of the budgets will be required.
  - Systems should use this time to review current drawdown of funding and develop plans to ensure maximum drawdown occurs on or before the end of availability for each fund source.

# Louisiana Numeracy Excellence Act

The Louisiana Numeracy Excellence (LANE) Act of 2025 expands the Act 260 (2023) requirements for numeracy professional learning.

- Act 260 requires all grades 4-8 math teachers to complete numeracy professional learning by August 2025.
- LANE requires all K-3 math teachers to complete numeracy professional learning by August 2027.

# LEADS Updates

- New dates have been released for LEADS evaluator training. All newly hired or appointed observers and evaluators should register for an upcoming training. The summer training will begin on June 1, with additional sessions offered in August, September, October, and November.
- Per Bulletin 130, all new hires are required to complete every component of the evaluation process, including all observations and SLTs. No exemptions are permitted for new hires.
- The deadline for completing 2024-2025 teacher evaluations has been extended. All evaluations should be closed by **January 31**.

# Act 479 (2025): Seclusion and Restraint Update

- Act 479 (2025) revised Louisiana's requirements for the use of seclusion and restraint. The Crisis Prevention Institute (CPI) is supporting school systems in implementing safe, compliant practices.
- This partnership provides guidance on the use of safety interventions and the safe administration of seclusion and physical restraint throughout the duration of a restrictive intervention.
- CPI will soon offer asynchronous learning opportunities through the Louisiana Professional Learning Platform.

# Dyslexia Core Assessment Support Program

- The Dyslexia Core Assessment Support Program application is now open, allowing families of students identified as “at risk” for dyslexia to apply for up to \$500 in reimbursement for a dyslexia core assessment completed by an LDOE-approved provider.
- The program webpage includes key details, the application portal link, and parent-facing communication materials outlining eligibility, the application process, and next steps.

**DYSLEXIA CORE ASSESSMENT SUPPORT PROGRAM**



If your child was recently identified as at risk for dyslexia through a school screening, the Louisiana Department of Education (LDOE) offers support to help families pay for next steps.

- Families may receive up to \$500 per student, per year toward the cost of a Dyslexia Core Assessment
- The assessment must be completed by an LDOE-approved provider
- Providers set their own pricing families may be responsible for any costs above \$500
- Approved providers are paid directly through the program

**WHAT IS A DYSLEXIA CORE ASSESSMENT?**

A Dyslexia Core Assessment is a more in-depth evaluation that helps determine whether a student has dyslexia or needs additional literacy support. The assessment may include:

- ✓ Reading and language skill checks
- ✓ Word reading and decoding activities
- ✓ A review of academic performance
- ✓ A brief family interview

  - This collection of data is used for calculating Value Added Model (VAM), Interest and Opportunities (I&O), budgeted salary reporting, teacher pay raises, and CTE and CDF Funding.
- The last day to submit all extracts to the EdLink 360 sFTP for the **February 1 MFP** collection is **February 11 by 5 p.m.**
  - This collection of data is critical to MFP funding and economically disadvantaged calculations.



- Any board action taken on such applications as part of the local district timeline shall be reported to the LDOE by January 30, 2026.
- State Legislators - Each state senator and state representative in whose district the charter school is to be located should receive notice whether the proposal was approved or denied in the form of postal and electronic mail.

- **February 2:** LDOE application opens for Types 2 and 4 applicants
- **February 9 (5 p.m. CST):** Letter of Intent due
- **March 9 (5 p.m. CST):** Eligibility Determination Form due
- **March 30 (5 p.m. CST):** Full Application due
- **August 18:** BESE considers applications for new Type 2 and 4 applicants



# 2026-2027 Early Childhood Coordinated Funding Request

Each Early Childhood Community Network Lead Agency (CNLA) is required to submit a Coordinated Funding Request (CFR) to the LDOE annually via Super App. The CFR provides CNLAs an opportunity to request funding for LA 4 and NSECD seats.

- CNLAs are required to provide opportunities for each publicly funded program in the network to participate in the development of, and comment on, the proposed CFR.
- Networks who are not LEAs are required to submit the CFR via e-mail to [accountability@la.gov](mailto:accountability@la.gov).

# 2026-2028 Community Network Lead Agency (CNLA) Request For Applications

Early Childhood Community Network Lead Agencies (CNLAs) are required by Bulletin 140 to participate in an approval process with the LDOE:

- CNLAs shall be approved by BESE.
- LDOE shall identify potential CNLAs through a competitive process and submit them to BESE for approval.
- Applicants for CNLA shall seek support from publicly funded programs within its designated community network by obtaining signatures and submitting them to LDOE in the competitive process.

# Coordinated Enrollment Plans

Early Childhood Community Network Lead Agencies are completing Coordinated Enrollment Plans and Coordinated Funding Requests (for LA 4 and NSECD seats) for the 2026-2027 academic year.

Coordinated Enrollment Plans include information related to how each network will do the following:

- Coordinate information so families are aware of all available early childhood programs with open seats in the community.
- Coordinate eligibility so families know the early childhood programs for which they qualify.
- Coordinate applications for enrollment, enabling families to apply to all birth-5 publicly funded programs through one application.
- Match families to available early childhood programs based on family preference.
