# **Differentiated Compensation Allocation**

State funds were provided by the Legislature to assist school systems and schools with their unique market needs in the recruitment and retention of teachers by providing different stipends for different jobs.

#### **Allocation Methodology**

- Number of teachers as reported in the latest available staffing data multiplied by \$289.93 plus retirement benefits at the FY 24-25 retirement contribution rates.
- Calculation uses the number of teacher positions reported in the Fall 2023 MFP staffing count.

#### **Funding Release**

• Funding will be released on or about September 5, 2024.

## **Differentiated Compensation Allocation**

Differentiated Compensation funding must be utilized for stipends in one or more of the four approved categories of uses. Stipends may be provided in any amount and are not required to be awarded in accordance with the allocated per teacher amount.

#### **Approved Uses of Funds**

- Stipends for teachers in critical shortage area as determined by BESE (secondary math, secondary science, or special education) and/or;
- Stipends for Highly Effective Teachers (as defined in R.S. 17:381 through 3095 Bulletin 130 Section 309), and/or;
- Stipends for teachers working in High Need schools defined as those with an Economically Disadvantaged rate of 85% or greater, and/or;
- Stipends for teacher leadership positions such as classroom teachers appointed to lead weekly teacher collaborations, or serve as coaches.

## **Certificated & Support Staff Stipend Allocation**

State funds provided by Legislature intended to support a stipend for Certificated and Support Staff. Funding will be allocated at a rate of \$2,000 for certificated staff and \$1,000 for Support Staff.

#### **Allocation Methodology**

- Calculation methodology and staff data mirror the MFP Level 4 pay raise allocations inclusive of retirement benefits at the FY 24-25 retirement contribution rates.
- The number of certificated and support staff positions utilized in the calculation were reported in the Fall 2023 MFP staffing count.

#### **Funding Release**

• Funding will be released on or about September 13, 2024.

#### **Distribution Deadline**

• Stipends must be distributed no later than December 15, 2024 unlike in prior years when the distribution date was determined by the school system.

## **Stipend Approval and Implementation**

#### **Approval and Implementation Requirements**

- Both the Certificated and Support Staff and the Differentiated Compensation stipends must be presented to and adopted by school boards prior to releasing payments to employees (required by Act 1 of 2012).
- Both stipends must be reported in the school system salary schedule documents notated as stipends, and should not be added to the permanent salary pay scales.
- Louisiana Legislative Auditors will require independent CPA firms to include testing for proper approval during the Single Audit within the State Agreed Upon Procedures testing.

## **ESSER III Amended Liquidation Protocols**

To afford LEAs the fullest range of flexibility in drawing down the ESSER III funding, the LDOE has implemented amended liquidation protocols given the recent flexibilities provided by ED.

Amended protocols apply to ESSER III funding only and allow additional time to liquidate:

- Goods
- Services
- Construction projects

Contracts must still be in place and purchase order requisitions must be submitted by September 30, 2024. LEAs have until December 16, 2024 to receive goods and complete services and construction projects.



## **School System Planning**

The 2025-2026 Super App in-person launch will take place on October 17 at LASAFAP. During the launch, the *Next Level Vision for Success School System Planning & Budgeting Workbook*, inclusive of 2025-2026 Super App questions, will be released.

#### New for 2025-2026

- The Next Level Vision for Success School System Planning & Budgeting Workbook serves as a one-stop resource for all school system planning needs.
- Super App questions and funding are aligned to the LDOE's updated educational priorities.
- The updated application in eGMS automates the review process and simplifies the steps of Super App submissions to ensure alignment with ESSA requirements for labeled schools.
- LEAs will be required to identify ESSA-required comprehensive support and improvement strategies to improve student outcomes.

# **High Dosage Tutoring**

Act 771 requires all students in grades kindergarten through five who failed to achieve mastery on any statewide assessment in reading or math to be eligible for expanded academic support. It requires one of the following:

- Prioritized placement in a class taught by a teacher labeled as "highly effective"
- High Dosage Tutoring

Applications are now open and plans are due **September 15** in eGMS. As soon as plans are approved, the funds will be released.

#### Data Certification for ACT, DCAI, Assessment

Data certification is now open for all school system accountability contacts to check the data that will be used to calculate the DCAI and ACT indices. In late August, assessment rosters were released in La Data Review for review.

This is the final opportunity for school systems to request changes to data. Data that is not corrected during a data certification review cannot be used to appeal the school performance score once it is released.

# **Kindergarten Entry Assessment (KEA)**

Kindergarten Entry Assessment (KEA) identifies the developmental levels of every child entering kindergarten for the first time through gathering of information concerning their interpersonal, language and literacy, math, cognitive, and physical development.

- The results of this assessment shall be used for measuring student readiness for kindergarten, planning instruction, and providing administrators and families information about each student's progress.
- Regardless of the chosen assessment (DRDP-K or TS GOLD<sup>®</sup>), the KEA must be completed within the **first 30 school days**.
- Districts should submit DRDP-K results to EdLink 360 or finalize TS GOLD<sup>®</sup> data in the platform by October 18.
