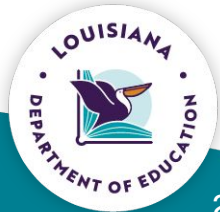

CLSD 2019 (CIR/UIR)

- CLSD CIR/UIR is finishing a no-cost extension year
- This current school year is the last year for this grant.
- We encourage you to spend every dollar.

CLSD 2020 (UIN)

- CLSD 2020 is going into a no-cost extension year.
- Allocations were proposed to BESE on April 8th and approved.
- Allocations will be loaded into eGMS, and LEAs will receive an email from project director with allocations by grade band.
- Currently, funds must be spent July 1, 2025 - September 30, 2025.
- Pending no cost extension, funds would be able to be spent July 1, 2025 - June 30, 2026.
- Last year of funding. Prioritize:
 - Growing teacher and leader capacity
 - Setting up sustainable practices and systems

CLSD UIN Non-Negotiables

- Implementation and tracking of pre-teaching, case management or family literacy coaching innovations
- Coaching from a Literacy Innovation Coordinator
- Attend monthly Community of Practice Meetings or SSI, depending on cohort. It is mandatory for the Literacy Innovation Coordinator, principal and another leadership team member attend.
- Participate in support/monitoring visits annually
- Update annual literacy plan to deliverable folder
- Literacy Team/ILT meetings at least twice a month with agendas
- A QOZ community partner is on file and attends ILTs at least once a month.

CLSD 2024

- This grant was awarded through a competitive process.
- Out of the 96 applications, there was enough funding to award 26 subgrants.
- CLSD 2024 Orientation will occur April 15th at 1 p.m.
 - Grant coordinator
 - Federal programs director
 - Anyone familiar with previous CLSD grants
- Review your CLSD application with your district team, including project plan, schools requesting funding, and your budget
- Reaching out to systems that were partially funded to discuss how much for each grade band, as well as anything in budgets that are not allowable.

- CLSD grants cannot be braided together to fund a salary.
- Please ensure purchases are to supplement and not supplant current initiatives.
- CLSD funds cannot be used to fund something that was funded by a previous iteration. This includes salaries.
- Federal grant funds cannot be used to fund activities required by state law.
