- If the computer is lost, stolen or damaged, parents/guardians/students should immediately contact the school's administration.
- The Chromebook device, device charger, and charger cord are the property of West Baton Rouge Parish Schools at 3761 Rosedale Rd, Port Allen La. 70767 and is being loaned to the student for educational purposes only until further notice. **Students must return the computer and related materials when requested.**
- Students **may not** deface or destroy this property in any way.

Internet:

- The user and his/her guardians should be aware that the West Baton Rouge Parish School Board **does not** control the information on the Internet nor can it provide comprehensive barriers to users accessing information.
- Sites accessible via the Internet may contain material that is illegal, defamatory, inaccurate, or potentially offensive to some people.
- The West Baton Rouge Parish School Board believes that the benefits to students from access to this technology and the Internet, in the form of information resources, information organization, modeling, and opportunities for collaboration far exceed any possible disadvantages of access.
