#### **Community Service Policy Updates**

Bulletin 741, Louisiana Handbook for School Administrators, states school systems may award a Community Service Diploma Endorsement to students who have completed total of <u>80 hours of community service in ninth</u> through twelfth grade.

Students may earn service hours identified in the <u>Community Service Diploma Endorsement Categories</u>. The <u>Community Service Opportunities</u> document lists ways to earn service hours while maintaining safety measures.

#### **Diploma Seal Logistics**

Who	Action Step
Student	Complete service hours and document efforts on the <u>Community</u> <u>Service Endorsement Documentation Form</u> .
School System	Use the <u>Community Service Diploma Endorsement Tracking Form</u> to summarize the student efforts. Documentation is housed at the local level.
School System	Use code "C1" in STS to document the student has met the Community Service Endorsement requirement.
School System	Order the Community Service Seals yearly using the electronic Diploma Order Form shared via the Department Newsletter. Orders should align with the number earned by students shown in STS.

### **Gifted and Talented Programming Self-Review**

#### All School systems should have received this document from my office.

#### §1149. General Supervision

- A. The Division of Special Populations is established within the department to provide general supervision of all education programs for gifted and talented students within the state. *General supervision* is defined as the responsibility to perform functions prescribed by the state board.
  - 4. The Division of Special Populations shall monitor according to written procedures the implementation of state standards in each public agency. Such monitoring shall include child identification and programmatic, administrative, and fiscal issues.
- Submission deadline: December 1, 2022

### **Definitions in Bulletin 1508**

#### **Chapter 9. Gifted and Talented**

#### §901. Gifted

A. Definition. Gifted children and youth are students who demonstrate abilities that give evidence of high performance in academic and intellectual aptitude.

#### §903. Talented

A. Definition. Talented means possession of measurable abilities that give clear evidence of unique talent in visual or performing arts or both.

### Why do I need to request a waiver?

A **waiver** is a formal request by your school system to "waive" the policy established in Bulletin 1706. It is only valid for one school year, so these forms are submitted annually.

#### **Reasons for a waiver:**

- Exceeding the Pupil Teacher Ratio allowances in Chapter 20
- Placement of nongifted students in a gifted class for the explicit purpose of increasing identification of gifted students
  - Examples: East Baton Rouge Parish-Scholastic Academy, Great Scholars, St. Charles Parish-Advanced Learning Program
- Greater than a 3 year age span in a gifted or talented instructional setting



#### **Waiver Process**

- 1. Complete a BESE regulation waiver request form and submit to <u>ashley.townsend@la.gov</u> along with a letter addressed to Shan Davis (executive director of BESE <u>shan.davis@la.gov</u>) providing a rationale and specific details concerning how and why the regulation would be adjusted.
- 2. Please copy me when it is submitted so that I may begin drafting the supporting documents that must be submitted to BESE.
- 3. All waivers have conditions for approval; documentation of the impact of the granted waiver is submitted to my office prior to the approval of subsequent requests.





### **Gifted and Talented IEP**

- Thank you for your patience as the department rolls out this new platform.
  - → Guidelines for developing the IEP are being developed.
- Use the gifted and talented initial or review IEP form for any student with a primary classification of gifted or talented.
- Students have a primary disabling classification should use the the IDEA IEP form.
  - → Check boxes are available for the gifted and talented classifications as secondary exceptionalities
  - → Gifted and/or talented minutes are not listed in the minutes; the same information is written in the comment section on the program services page.





### **Gifted Instructional Settings**

Only gifted students should be enrolled in a gifted instructional setting.

- → Nongifted students in a gifted instructional setting nullifies the special minutes indicated on the IEP.
- Only talented students should be enrolled in a their talented instructional settings, as determined by their discipline.
- → Non-talented students in a talented instructional setting nullifies the special minutes indicated on the IEP.

**Instructional minutes are determined by the IEP team,** based on the needs of the student and available resources, not on administrative convenience.

→ Amendments must be completed to change minutes or goals on an IEP.



### **Certification of Gifted Teachers**

#### §623. Requirements to add Academically Gifted

- valid teaching certificate
- master's degree
- 15 graduate degree hours
- 3 practicum hours or 3 year of gifted teaching experience
- secondary teacher must be certified to teach the content area for a Carnegie Unit





### **Certification of Talented Teachers**

Talented: §343. Artist or Talented Certificate

#### Artist certificate:

- specific to artistic field
- substantive evidence of accomplishments
- written request from school system stating individual will be employed in that capacity

#### Talented certificate:

- specific to artistic field
- substantive evidence of accomplishments or Master's degree in content area
- written request from school system stating individual will be employed in that capacity



### **Provision of G/T Services**

- 1. MFP funding is determined by your current IEP's
  - October 1, 2022
  - Funding is for the provision of gifted and talented services
- 2. Schools systems may determine the type of programming offered to the students
- 3. Course codes for gifted and talented programming
