#### Short Instructional Technology Survey

In next Tuesday's newsletter the Department will share a short (10 minute) instructional technology survey.

- **Purpose**: We aim to improve the functionality and use of CIS, Eagle, and CVR over the coming years. In order to begin this work and build systems to support districts, we need a better understanding of the other platforms used across the state.
- **Dates**: The survey will go out in Tuesday's Superintendent's newsletter. It is due by September 12<sup>th</sup>.
- **Time**: The survey will take 10-20 minutes to complete.
- **Who**: Please encourage your academic leads, technology leads, and DTCs to complete the survey (districts can have multiple responses).

Thank you in advance for this quick information. It will help us build better tools to support you.

#### Assessment

The Department is committed to sharing timely information about the state's 2014-15 assessments.

**3-8 Assessments**: The Department will communicate end of year testing plans by August 31<sup>st</sup>. This will include the plan for science, social studies, LAA 1, LAA 2 (HS) and ELDA, the implementation of which have been suspended by the Administration.

The state assessments in grades 3-8 ELA and math will be consistent with previous plans in Louisiana. The questions included in the <u>ELA</u> and <u>math</u> guidebooks are the types of questions students will see on the grade 3-8 end of year assessments this year. From a teacher's perspective, these academic issues will not change from previous plans, no matter the result of lawsuits.

**High school assessments**: The high school End-of-Course assessments will remain aligned to the Common Core standards, as they were in 2013-14. <u>Assessment Guidance</u> documents for 2014-15 are posted on the Department's website and provide details on those assessments.

# Supplemental Course Allocation

The MFP includes a Supplemental Course Allocation (SCA) enabling every school district and charter school to fund courses not typically provided by high schools to all eligible students.

#### SCA courses will include:

- Career and technical preparation
- Academic work required to achieve TOPS
- Advanced coursework not available at the school due to limited resources
- Dual Enrollment
- Intensive remediation for students struggling to stay on pace for graduation

## Advanced Placement Update

The number of college credits earned in 2014 by Louisiana students on Advanced Placement (AP®) exams increased by more than 1,250 credits over results in 2013 - the greatest increase in number of credits earned in state history.

The Department has posted Advanced Placement outcomes by school and district in the state's secure portal.

This month the Department supported LEA's in identifying students with high potential for AP® success by notification letters to each LEA through Network teams.

Letters were addressed to the parents or guardians of students demonstrating a high likelihood of AP® success based on results from the 2014 ACT PLAN® Assessment taken during sophomore year.

#### **Data Certification Timeline**

The data certification is currently in progress and allows districts time to certify, update, and review data used for calculating school performance scores.

Any assessment errors that are not corrected during the data certification window shall not be used as grounds for an appeal or waiver request regardless of the source of any errors (Bulletin 111, Section 3107).

# Data Privacy: Act 837 Overview

Act 837 provides for limitations and prohibitions on the collection and sharing of student information:

- Prohibits LEAs from requiring the collection of non-academic data about students such as political affiliation, religious practices, or information.
- Restricts LEAs from sharing personally identifiable information (PII) about students with external entities, including LDE, starting June 1, 2015. The law provides limited exceptions:
  - LEAs may share students' personally identifiable information with LDE if:
    - The parent has given written consent to share that information.
    - The state requires it for auditing, including enrollment counts.
  - LEAs may share PII with a private entity if they contract for student and other education services.

# Data Privacy: Act 837 Overview

- Requires the Department to create a unique statewide student identifier system by
   May 1, 2015. The unique student identifiers must not include or be based on social
   security numbers, and students must retain their unique identifier throughout their
   tenure in Louisiana public schools. LEAs must assign unique IDs to all students
   enrolled in public schools by June 1, 2015.
- Prohibits anyone from accessing student information that is stored by schools or LEAs except authorized stakeholders such as parents, teachers, principals, or a person authorized by the state to audit student records.
- Requires any contract through which an LEA shares students' PII to include specific terms outlined in the law.
- Requires LEAs to gather parental consent annually for sharing PII with postsecondary institutions for purposes of admission and financial aid.

# Act 837 Next Steps

#### The Department will:

- Immediately issue a request for proposals to create a unique statewide student identifier system, assign student unique identifiers, modify LDE's systems, and provide training to State and LEA staff.
- **Identify processes** that currently require the sharing of personally identifiable information between LDE and LEAs. LDE expects that Act 837 will not affect the vast majority of LDE's interactions with LEAs in the 2014-2015 school year.
- **Provide guidance** to LEAs about how each of the processes will be affected and the actions the Department and LEAs will need to take.
- Identify and clarify auditing processes and the data required from LEAs to conduct quality audits.
- Offer in-person regional training opportunities on how to use and integrate local systems with the unique statewide student identifier system.
- Communicate regularly with all district level stakeholders about the transition process.

#### **LEA Actions**

- Meet with your data, technology, assessment, and special education leaders as well
  as other affected administrators to review the legislation and identify implications
  for your work.
- **Review the request for proposals** once it is released to better understand the functionality of the unique statewide student identifier system.
- Review existing contracts that involve the sharing of personally identifiable information about students to ensure they include the required terms.
- Assess current levels of access to your computer systems and ensure that authorized stakeholders have appropriate access to student information.

#### E-Rate 2.0

The first E-Rate (2.0) modernization order (FCC 14-99) has been released and it includes significant changes to the E-Rate Program

#### New goals and measures

 Ensuring access to high-speed broadband, cost-effectiveness measures, streamlining application process

#### Support of internal connections

New per student funding for Category 2 services, lower discount funding bands

#### • Eliminating, phasing-out, and narrowly defining support for "legacy" services

Eliminating support for many services (E-mail, web hosting, inside wire maintenance), phase-out
of voice service support (local and long distance phone – both POTS and VoIP), and support for
cellular digital plans

#### Maximizing cost effectiveness

 Transparency on costs for services and hardware, priority review/funding for consortium applications, and new "preferred master contracts"

#### Simplifying the E-Rate process

• Streamlined multi-year contract filing, elimination of technology plans, some Internet services will be exempt from competitive bidding, and all applications must be electronically filed

#### Community Eligibility Provision

#### Program Overview

• Community Eligibility Provision (CEP) is a National School Lunch Program (NSLP) option that allows schools to offer breakfast and lunch at no charge to <u>all</u> students

#### **Benefits**

- More students receive free meals
- Eliminates administrative burden of processing applications
- Parents no longer complete cumbersome application process

# Participation Eligibility

 LEAs, groups of schools, and/or individual schools of which 40% or greater of its student population has been directly certified as eligible for free meals. (see <u>CEP</u> <u>website</u> for full list of approved programs/certifiers)

#### **Implications**

- Participation will not dramatically impact 2014-2015 funding and reporting.
- Financial simulations related to formula funds (Title I, II, IDEA, Perkins) are now available via sFTP

#### Preliminary Results

• As of 8/14, 15 districts have signed up for partial or full implementation of CEP; this will lead to free meals to students in 183 schools

# 2014-2015 High Cost Services Allocation

**Update:** Of the 88 LEAs that applied for the HCS grant, 85 LEAs and 465 students were determined eligible for HCS funds.

- The Total Eligible Request for the City/Parish LEAs is \$15,092,892
- The Total Eligible Requests for the Charter Schools is \$5,139,074

The total allocation for HCS is \$8 million. Awards will be based on number of eligible students and the impact of the eligible students' costs on the LEA's budget.

**Next Steps:** The recommended allocations will go to BESE in October and will also need approval from JLCB.

# Education Excellence Fund (EEF)

#### **Education Excellence Fund:**

Districts are encouraged to use Educational Excellence Funds to support goals and priorities aligned with Focus Areas Outlined in the <u>District Planning Guide</u>.

**Total Funding:** Over \$800,000 available to over 300 public and non-public education agencies

**How to Apply:** online using the Electronic Grants Management System (eGMS) beginning **Monday, August 25**<sup>th</sup>

**Application Due Date:** applications will be processed until **Friday, October 3<sup>rd</sup>** Note: No paper applications will be accepted
