The table below provides a side-by-side comparison between current common Louisiana accommodations and accommodations available on the PARCC field test for Spring 2014. These accommodations encompass those available for students with IEP/504 plans and students who are English language learners.

Features on the PARCC test fall into three categories: features for all, accessibility features and accommodations.

#### **Features for all students:**

- Tools built into the assessment such as choice elimination, line reader
- Does not require an 'opt in' prior to the test

#### Accessibility features for all students that need to be 'turned on':

- Available to any student taking the PARCC assessments
- Allows for even more individualized support for students
- Students/teachers 'opt in' to these features during or prior to the test
- Includes answer masking and color contrast

#### **Accommodations:**

- Aligned to students' IEP or 504 plans
- Also available for ELL students

KEY: Computer Based Testing (CBT) – Indicates which category of support is available for the PARCC Computer-Based Testing Paper and Pencil (PBT) – Indicates which category of support is available for the PARCC Paper and Pencil Testing Performance Based Assessment (PBA) – This is the Phase I test administered in March End-of-Year Assessment – This is the Phase II test administered in May
