Teaching & Learning: Standards Update

Legislative Action Related to Standards Transition

The Legislature is currently considering a compromise regarding standards and accountability.

- The new Louisiana Student Standards will be implemented in 2016-2017.
- The accountability, student promotion, and Compass transition policies will continue through the 2016-2017 school year.
- After the transition policies conclude and the calculation of value-added data resumes, student growth will continue to count for 50 percent of a teacher's evaluation. However, value-added will make up only 35 percent of a teacher's evaluation.

For the 2016-2017 school year, as in the past three years, BESE's transition policies will remain in place, resulting in the following:

- Promotion decisions will continue to be made locally.
- Teacher value-added data will not be calculated.
- School and district letter grade distributions will not drop below the 2012-2013 distribution.

LEAP 2025 Assessments

The Department will seek a vendor through a competitive bid process to provide a uniquely Louisiana test called LEAP 2025 with questions based on Louisiana Student Standards.

The procurement process determines a vendor; the Louisiana Student Standards determine the content of the test.

The RFP will seek the following:

- Uniquely Louisiana summative assessments in grade 3 through high school (i.e., English I, Algebra I, English II, and Geometry)
- Optional non-summative assessments
 - Formative assessment tasks for K through 2, for use at the discretion of districts
 - Diagnostic assessments for grade 3 through high school, for use at the discretion of districts
 - Interim assessments for grade 3 through high school, for use at the discretion of districts
- Support resources (e.g., assessment guides, practice tests, released items)

LEAP 2025 Assessments

The uniquely Louisiana assessments will be

- aligned to the Louisiana Student Standards;
- designed to be accessible for use by the widest possible range of students (e.g., students with disabilities, ELL students);
- constructed to
 - yield valid and reliable test results,
 - report student performance using five achievement levels, and
 - be comparable with a significant number of other states;
- developed to limit the amount of testing time;
- developed and reviewed with Louisiana educator involvement; and
- administered online in grade 3 through high school and online or on paper in grades 3 and 4.

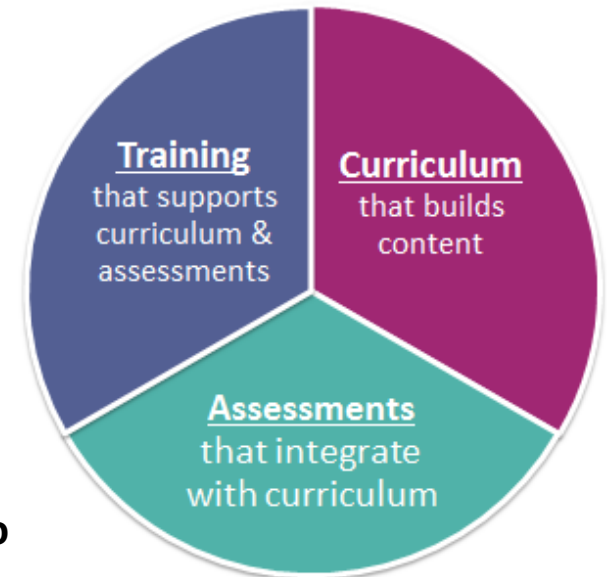

The goal for students in English language arts (ELA) is to read and understand complex, grade-level texts and express their understanding of those texts through writing and speaking.

- [ELA Guidebooks 2.0](#) is a curriculum for whole-class instruction made by Louisiana teachers for teachers to ensure all students meet the ELA goal.
- The content is free and openly licensed under a [CC-BY 4.0 license](#). This means the units can be used, printed, shared, and adapted without any permission needed.
- What makes [ELA Guidebooks 2.0](#) different from other curricula?
 - Real learning grounded in text
 - Plan for students, not programs
 - Support is central to the design

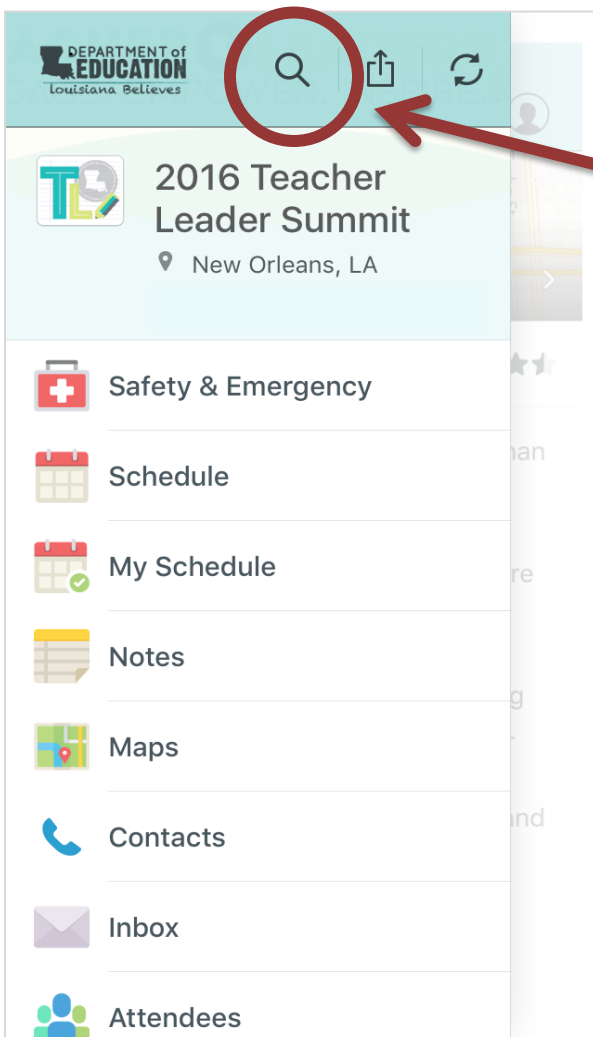

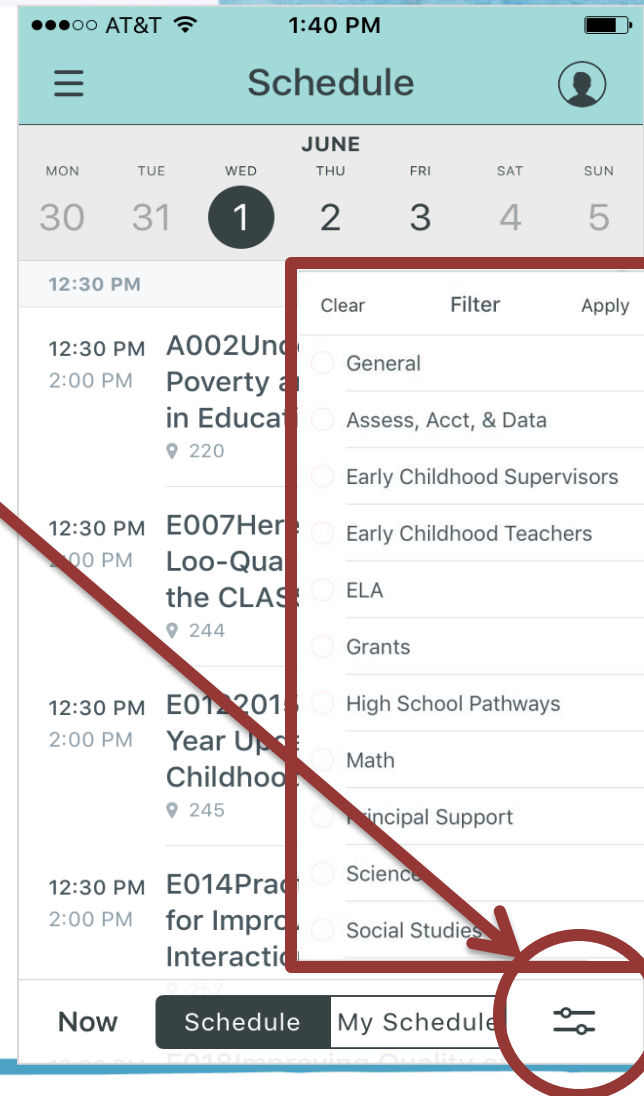

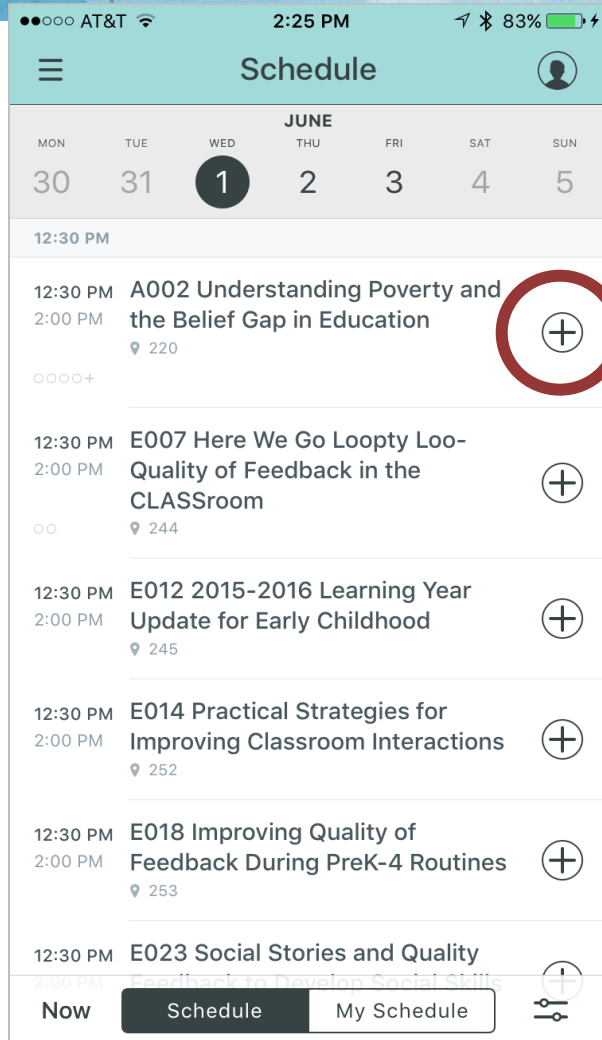

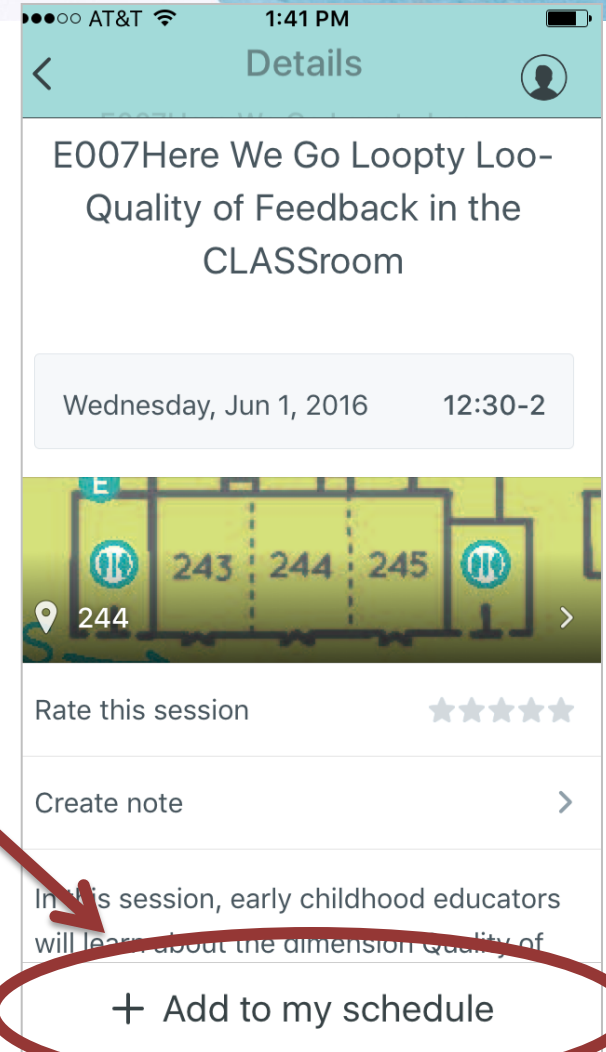

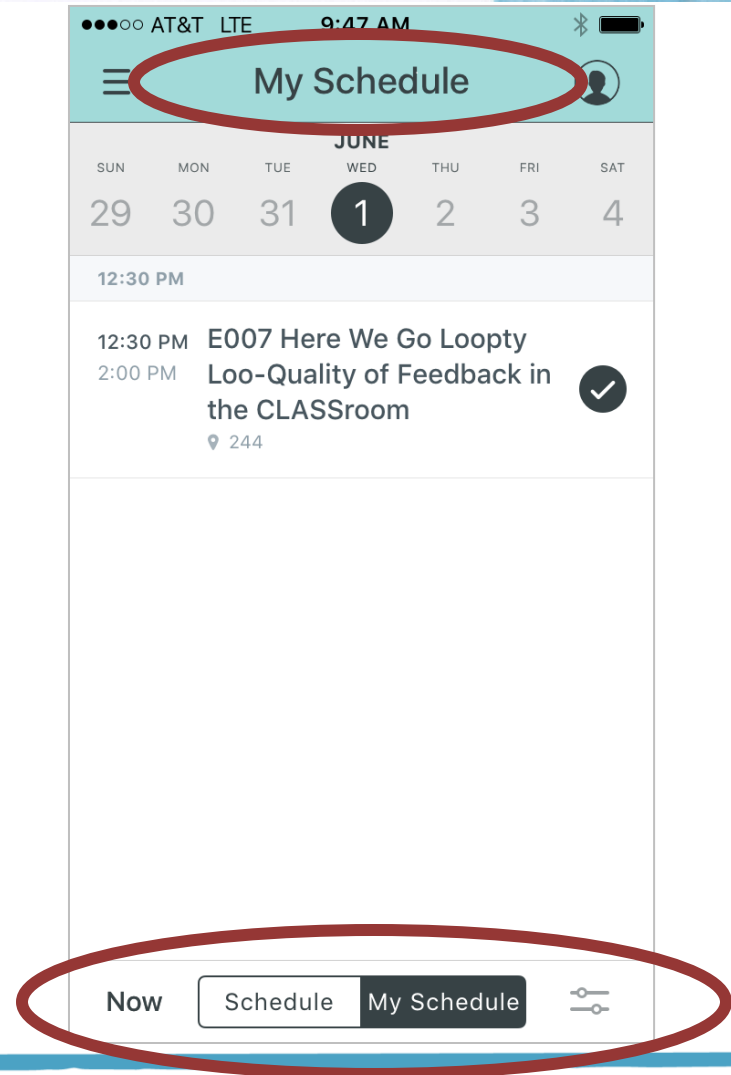

2016-2017 Early Childhood Guidance

What matters most in early childhood settings is that children have opportunities to develop competencies and skills across all domains of development, from social-emotional to language and literacy, so they enter kindergarten prepared for success.

This means early childhood educators must focus on key areas:

- Providing effective classroom interactions and instruction connected to content and routines
- Using high-quality resources, including curriculum materials and assessment tools, to strengthen children's development and learning

The Department has released [guidance](#) to support early childhood teachers in implementing strong and coordinated curriculum, assessments, and professional development that promote the quality and continuity of practice across early childhood and early elementary settings.

Teaching & Learning: Compass Updates

Compass: End-of-Year Ratings

Evaluators of principals and teachers are able to use multiple measures of student growth and professional practice to support improvement through the year and to determine end-of-year ratings.

Student Growth: Multiple Measures

Teachers:

- Student learning targets (goals)
- Student growth data (VAM/TSGD where available)

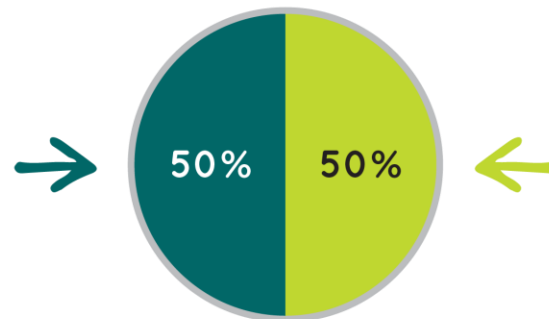
Principals:

- Student learning targets (goals) based on School Performance Scores (SPS)

Starting in 2016–2017, leaders may adjust the student outcomes score for teachers with value-added data by +/-1 from the VAM rating, based on SLT results.

Final Evaluation

Both the Student Outcomes and Professional Practice components contribute equally to the final evaluation rating for both teachers and principals.



An ineffective rating on student outcomes or professional practice no longer overrides a principal's evaluation of his/her employees.

Professional Practice: Multiple Measures

Teachers:

- At least two observations measured using a tool aligned to instructional standards

Principals:

- At least two site visits to observe evidence of leadership practices
- Measured using a tool aligned to established leadership standards

School systems and school leaders decide the following regarding teacher observations:

- *number and length of observations beyond the minimum*
- *scope of observations including number of rubric indicators and type of evidence collected*

Believe and Prepare Updates**

Believe and Prepare Policy Development

Believe and Prepare pilot leaders, as well as academic research, depict promising practices in teacher licensure and preparation that could be the basis for long-term, statewide policy after years of committed study.

In order to expand these practices, the Department seeks to make policy changes. But the Department proposes that policies first be piloted, ensuring regular review and adjustment before final effect. Thus proposed bulletin changes include the following elements:

- Preparation program experience descriptors, including a gradual, year-over-year shift to competency-based program designs and yearlong residencies for all teacher candidates
- Teacher licensure policies, including piloting and potential adoption of content knowledge assessments aligned to Louisiana Student Standards
- Preparation program approval policies, including a multi-measure, quality rating system (that is Higher Education Act-compliant) with comparable measures for both traditional and alternative providers to be phased in over six years

This summer, BESE will be asked to approve a schedule for continued design, piloting, and regular evaluation of policies over the next six years, to be fully phased in by 2020-2021.

Believe and Prepare Grant Opportunity

School system and preparation provider leaders have identified further opportunities for the Believe and Prepare community, including the following:

- Growing **competency-based** preparation experiences that include **yearlong residencies**
- Increasing the number of teachers in **high-need schools and certification areas**
- Expanding the cadre of **effective mentor teachers**
- **Expanding partnerships** to geographically remote districts


The Department plans to release a **Believe and Prepare Cohort 4 RFA** in **early summer**. The RFA will prioritize supporting program changes and expanding partnerships through 2016-2017 and allow preparation providers to serve as the lead applicant.

The application period will extend through August to allow school systems and preparation providers to collaborate on the application.

Funding will be available this fall, pending BESE approval.

Computer-Based Testing Update

- In this first year of computer-based testing in grades 3 through 8, 16 traditional school districts and a number of nonpublic and charter schools chose to test one or more schools or grade levels using the online testing platform, INSIGHT.
- During the math and ELA window, over 100,000 sessions were completed by these schools.
- Almost every district across the state participated in online practice tests in the same platform with over 160,000 tests completed and another 18,000 currently in progress.
- The social studies field test window will end May 20. All but a few districts across the state participated in the online field test. These districts have already completed over 250,000 test sessions.

K8 Social Studies Index

In 2015-2016, test results from the social studies field test will not be used for accountability purposes. The 2016 K8 school performance score will include the 2013-2014 or 2014-2015 social studies assessment index, whichever is higher. The Department posted the social studies indices for schools and districts to the secure FTP on April 29 with filename “2016 K8 SPS Social Studies Index LEAcode.”

Early Childhood

Wrapping up 2015-2016

The state is near completion of the learning year:

- All spring *CLASS* observations must be confirmed by May 20.
 - Every early childhood classroom in a publicly funded site must have a local observation entered for the spring semester.
 - These observation scores will be used for the practice performance ratings that will be released in the fall.
- The Final Teaching Strategies *GOLD* Checkpoint is May 31.
 - Completing a checkpoint for every publicly funded child helps teachers and administrators understand where each child is and how they can best support the child.
 - Teachers and administrators should also enter their informational metrics in *GOLD*, including their ratio, curriculum, and degrees/credentials.
- The Department is reviewing [lead agency](#) applications, which were due on May 16. Lead agencies will coordinate observations, enrollment, and administration for community networks.

Preparing for Next Year

The Department is preparing for 2016-2017:

- The Department is making revisions to Bulletin 140 in the following areas based on feedback from the field via roundtables in April:
 1. Adjust scale from 3 levels to 4 levels to show differences in performance
 2. Implement consequences for consistently very low-performing sites
 3. Publicly honor excellence and improvement
 4. Focus greater attention on local observer accuracy
- Policy shifts are being reviewed at the [Early Childhood Advisory Council](#) meeting currently taking place and at June BESE.

Graduation Pathways

TOPS Processing: 2015-2016 Graduates

- In order for LOSFA to process TOPS awards for 2015-2016 in a timely manner, LEAs should complete data submissions for all high school graduates in the Student Transcript System (STS) no later than **5:00 p.m. on May 30, 2016.**
- Please verify graduation requirements are met, ensure all graduate records contain a graduation date, and certify all sites.
- The STS system will be reopened as soon as the LOSFA harvest is complete on May 31, 2016, so LEAs can continue to process remaining students.

Jobs for America's Graduates–Louisiana (JAG-LA)

The JAG-LA Program is an affiliate of the Jobs for America's Graduates Program (JAG), the nation's largest dropout prevention and recovery program serving youth 12 to 21 years of age.

JAG-LA delivers a unique set of services for at-risk students to help them earn a high school diploma and for out-of-school youth, to assist them in earning a Louisiana High School Equivalency Diploma. Services are provided by a job specialist and are centered on the national JAG competencies which include: career development, job attainment, job survival, communication skills, workplace skills, and life survival skills.

The program also provides 12 months of post-graduation follow-up services, with the graduate pursuing postsecondary education and/or entering the workforce in a quality job leading to a career.

2016-2017 Course Choice/SCA Registration

- In order to provide school systems with a more streamlined process for enrolling students in Course Choice and SCA courses, the Department will no longer process registration through the Agilix System in 2016-2017.
- LEAs will directly register students with approved providers and report back aggregate enrollment information to the LDOE.
- Students will register directly with Louisiana postsecondary institutions as they have in the past—no change.

- The **Pupil Progression Plan (PPP)** is the comprehensive plan developed and adopted by each LEA that establishes policies and guidelines that local school districts use to determine whether students will be promoted to the next grade, retained in the current grade, or advanced (or skipped) to higher grades. PPPs also outline the criteria for high school graduation.
- The new 2016-2017 PPP template will be released in June following the legislative session, via the superintendent's weekly newsletter and will be posted to the Department's website. As such, **the deadline for submission will be extended into mid-October.**
