



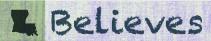

Policy Timeline Overview

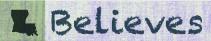
2017-2018	 LDOE launches a statewide training initiative to develop a cadre of Mentor Teachers and Content Leaders BESE approved regulations to establish mentor teacher and content leader credentials in the form of an ancillary certificate.
2019	 LDOE begins to issue Content Leader and Mentor Teacher ancillary certificates to individuals who have successfully completed a state-approved Content Leader or Mentor Teacher training program, including state-led training, and have a passing score on the Louisiana Content Leader or Mentor Teacher Assessment Series
2020	Mentor Teacher ancillary certificate required for individuals who serve as a mentor of undergraduate or post-baccalaureate teacher residents



Funding Overview

In the 2021-2022 academic year, the data collection for the mentor stipend will take place using the same process that was used in 2020-2021.


- The Department continues to provide a \$1,000 stipend to the mentors who support year-long undergraduate residents. This stipend is allocated to school systems who host residents. School systems should pay mentors directly. Taxes and benefits are not included in the allocation amount.
- Through the teacher pay increase approved by the Legislature in 2019, the
 Department will allocate funds for LEAs to pay \$1,000 to yearlong undergraduate
 residents who hold a resident certificate and are completing their residency in a
 public school.
- Funding will be provided through the Minimum Foundation Program (MFP) formula via the certificated pay raise calculation.



Eligibility

Who is eligible for the resident teacher pay raise compensation?


- The resident must hold a resident certificate with a valid from date on or before October 1,
 2021. (It is suggested that providers apply for resident certificates by September 1 to ensure they are processed in time for the stipend.)
- The resident must serve in a MFP funded entity.
- The resident must serve with a mentor teacher in the same MFP funded entity as the resident teacher.
- The resident must serve with a mentor teacher that is reported in PEP with an object code of 112 (teacher) and a function code within the 1000s excluding 1530 (Pre-K) and 1531 (Head Start).
- The resident must serve with a mentor teacher that is not a contract employee.
- The resident must serve with a mentor teacher holding one of the following on October 1,
 2021: Mentor Teacher Ancillary Certificate, Provisional Mentor Teacher Ancillary Certificate,
 Supervisor of Student Teaching Certificate, or 2021-2022 Mentor Credential Waiver



Eligibility

Who is eligible for the mentor teacher stipend?

- Mentors of certificated **undergraduate** residents in yearlong residencies are eligible for a \$1,000 stipend.
- The mentor teacher must hold one of the following on **October 1, 2021**:
 - Mentor Teacher Ancillary Certificate
 - Provisional Mentor Teacher Ancillary Certificate
 - Supervisor of Student Teaching Certificate
 - o 2021-2022 Mentor Credential Waiver




Resident and Mentor Teacher Data Collection



Data Collection Timeline

August	Funding data collection process communicated to School Systems and Preparation Providers
September	LDOE Team generates list of residents based on resident certificates issued for the 2021-2022 Academic Year or issued in Spring for the 2020-2021 Academic Year Providers complete a review of residents and LEAs indicated on resident certificates
October	School Systems report Resident teacher and Mentor teacher data Preparation Providers and School Systems validate and sign off on Mentor/resident list
November	Department compiles allocation counts for Mentor stipends
December	Preparation Providers and School Systems receive final funding list with rationale Resident teacher information is reported for MFP allocation BESE receives allocation counts for Mentor stipends



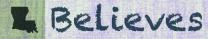

Preparation Providers

Preparation providers will receive and review the current list of resident certificates valid for the 2021-2022 academic year. The file will be sent to providers via email. Providers will review the file for the following:

- If the resident has withdrawn from the program.
- If the residency placement LEA listed in TCMS needs updating.
- If any residents you have applied for their certification, but are not included on the list.

Preparation programs should make all needed changes through the certification portal.

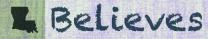

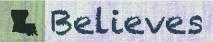

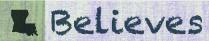

The resident list will be sent through the FTP and the template can be found in the preparation library on LouisianaBelieves.com. On the template, school systems will indicate:

- Residents completing their yearlong residency at their school system.
- Mentor teachers assigned to yearlong residents.

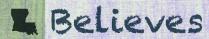
Preparation providers must submit their completed template through the FTP process by end of day on October 29, 2021.

Instructions to ensure we receive the information securely via FTP:

- 1. Review and update the file with all of the requested data.
- 2. Save your file with the following title:

"SchoolSystemCode_SchoolSystemName_ResidentandMentorTeacherData2020-2021_Final".

- 3. Securely share the file with the FTP Coordinator from your school system.
- 4. Ask the FTP Coordinator to upload the file to the FTP.
- 5. Send an email to BelieveandPrepare@la.gov to let LDOE staff know the file is uploaded.

Preparation Providers and School Systems

Preparation providers and school systems will receive a preliminary list of resident teachers and mentor teachers that will receive the stipend and the rationale if they did not. The list will be sent through the FTP.

Upon receiving the list, preparation providers and school systems should review the following:

- All residents serving in the 2021-2022 academic year have been reported
- Rationale for residents and mentors that will not receive the stipend

If any updates need to be made, please email <u>BelieveandPrepare@la.gov</u> and LDOE staff will resolve updates on a case by case basis. Updates must be communicated to the LDOE by **November 19, 2021**.



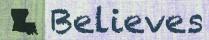



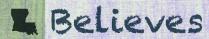
