Meaning of certificate	Instructor has documentation proving skill in one or more craft levels. Instructor can certify trainees in the areas certified.	Instructor holds the IBC from NCCER showing completion of a craft or level.

Instructors with NCCER Craft Instructor Certification

- Current NCCER Craft Instructors who do not hold a NCCER IBC in areas they are teaching may still certify students (per NCCER Guidelines)
 - However, to offer and transcript a <u>Career Development Fund Jump Start</u> <u>"Technical Course"</u> aligned to a statewide IBC, the instructor must hold the IBC in the title of the NCCER Course
 - **EXAMPLE**: A district that is teaching Welding Technology as opposed to NCCER Welding I would only receive 6% funding, which is approximately \$240 as opposed to approximately \$480/student for a Jump Start CDF pathway

Adding Levels to a Craft Instructor

- Documentation of skill set beyond current NCCER
 Specialty Instructor area may be provided to State
 Sponsor Representative.
 - After review and approval, this area will be added to instructor's certification.
 - Acceptable documentation is a resume or proof of holding other IBCs in the skill area
- Completion of NCCER Craft Level will be acceptable documentation
 - Note that completion of NCCER Core Curricula is a prerequisite for Level One completion in most craft areas.

Maintaining ICTP Certification

- Completion of ICTP certifies an instructor 3 years from the completion date of the class
- To maintain certification, the instructor must have Form 200 approved by NCCER before expiration date of Craft Instructor Certification.
 - ICTP will be extended 3 years from completion date on Form 200
 - ICTP will extend all craft instructor certifications regardless of module listed on Form 200

 - Because level completions exist, certification is based on documentation

Timeframe	Key Activity
May	 Next round of graduation pathway submissions are available for adoption (Maritime, Micro-Enterprise)
	 Regions can continue to submit their pathway adapt / adopt spreadsheets, indicating the graduation pathways they want to use with their students
	 Jump Start Graduation Pathway Review Panel meets to consider new graduation pathways (for approval by BESE in June)
	 Graduation pathway "harmonization" (typo corrections, common formatting, consistent course listings, etc.) begins
June/July	 Course Choice registration for courses that help students complete their Jump Start credentials, and which qualify for the CDF payment (~\$240/course credit)
	• Student Summer Safety Sessions - 5 locations, 100 students across the state attain the three credentials required for the Workplace Safety graduation pathway
	 Super Summer Institute - teacher certification training for Industry Based certifications
	Graduation pathway "harmonization" complete

2015 Jump Start Super Summer Institute

LDOE, in partnership with SLCC and LCTCS, will provide teacher certification training for Start Industry Based Certifications at the 2015 Jump Start Super Summer Institute (SSI).

Date: July 20 – 24 from 8:00am – 5:00pm

Location: South Louisiana Community College in Lafayette, La

The Department will pay training costs as well as lunch for secondary instructors during SSI. Districts are responsible for all travel expenses and a nominal registration fee (\$150.00/person) for which districts may use their Career Development Funds (CDF) or 2014-2015 Carl Perkins Funds.

Registration is April 8 – May 8, 2015 and requires teachers to input a District Purchase Order number that will be used for payment of registration fees. Each district will be invoiced for total registration fees due and will submit payment accompanied with a copy of the on-screen registration confirmation / message for all teachers registered.
